## WAIVER AND RELEASE OF LIABILITY

In consideration for permission by the Illinois Conservation Foundation (ICF) to participate in activities at the Torstenson Youth Conservation Education Center (TYCEC), I, \_\_\_\_\_, the

undersigned, acknowledge, appreciate, and agree that:

- 1. Identification of Risks.** Participation in any ICF/TYCEC activities involves risks of injury and loss, both to person and to property, including the possibility of permanent disability and death. I understand that these risks include, but are not limited to: handling firearms and being near others that have firearms in their possession; injury from ammunition and shot from other guns; walking in rugged country, including encounters with wildlife, animals, insects and water; inclement weather conditions; injury from riding on an all-terrain vehicle (ATV) or any vehicle used off the paved road; and the risk of injury from the use of tree stands. I understand that this Waiver and Release of Liability is intended to address all of the risks of any kind associated with participation in any aspect of TYCEC activities, including such risks created by actions, inactions, or negligence on the part of ICF/TYCEC staff, or its respective directors, officers, trustees, employees, agents, volunteers, successors, or assigns.
- 2. Voluntary Participation and Assumption of Risk.** I understand that participation in ICF/TYCEC activities is voluntary, and I voluntarily assume personal responsibility for any injury, liability, loss or damage arising from any and all risks, known and unknown, in any way connected with participation in ICF/TYCEC activities.
- 3. Release, Waiver and Covenant Not to Sue.** I release the ICF, the Illinois Department of Natural Resources (IDNR), and any ICF or IDNR officers, employees or agents, from, and waive all claims. I further covenant not to sue the ICF or IDNR for any liability, injury, loss, or damage, including attorneys' fees, in any way connected with participation in ICF/TYCEC activities, whether or not caused in whole or part by the negligence or other misconduct of ICF or IDNR.
- 4. Indemnification.** I agree to indemnify and to hold harmless (in other words, to reimburse and to absolve from responsibility) the ICF and/or IDNR from all claims for any liability, injury, loss, damage, or expense, including attorneys' fees (including cost of defending any claim I might make, or that might be made on my behalf, that is released or waived by this instrument), in any way connected with or arising out of my participation in ICF/TYCEC activities, whether or not caused in whole or in part by the negligence or other misconduct of the ICF or IDNR staff.
- 5. Consent to Medical Treatment.** I authorize ICF/TYCEC staff to provide to me, through medical personnel of its choice, customary medical assistance, transportation, and emergency medical services. This consent does not impose a duty upon the ICF/TYCEC staff to provide such assistance, transportation, or services.
- 6. Binding Effect, Severability, and Applicable Law.** This instrument shall be binding upon my relatives, personal representatives, heirs, beneficiaries, next of kin, or assigns and shall inure to the benefit of the ICF. If any provision (or portion of any provision) of this instrument is held to be invalid or unenforceable in part or in whole, such invalidity or unenforceability shall not otherwise affect any other provision of this instrument to the extent permissible by law. This instrument shall be governed, construed, and enforced in accordance with the law of the State of Illinois.

7. **Photographs and Videos.** I understand and agree that photographs and videos are periodically taken of participants, and that the ICF may use these photographs or videos in future publications. For valuable consideration, which is hereby acknowledged, I irrevocably transfer any rights or interests that I have or may have to such photographs, videos, or parts thereof (collectively the “Images”), to the ICF. I waive any privacy and publicity interests which I may have in such Images. I understand that the ICF may use, or not use, the Images at its discretion, for any lawful purpose.
8. **Licenses and Permits.** I understand and acknowledge that I will possess and be current with all required licenses and permits, as may be necessary, to participate in ICF/TYCEC activities.
9. **Rules and Instructions.** I understand and acknowledge that I will comply with the event or activity’s rules and the instructions, whether written or verbal, of the ICF, its directors, officers, employees, agents and volunteers, including event instructors, while participating in the event or activity.
10. **Parent/Legal Guardian Consent:** If the participant is a minor (under 18 years of age), the minor participant’s parent or legal guardian is also required to sign this form. By signing this Waiver and Release of Liability Form, the parent or legal guardian expressly (a) grants permission to the named participant to take part in ICF/TYCEC activities, (b) understands, acknowledges and affirms all the statements, assurances and waivers contained herein, and (c) agrees to bind himself or herself, and the minor participant, to each of the foregoing provisions to the extent permissible by law.
